The last twelve months have been a whirlwind at Tiny Miracles! As you read in our November newsletter, we solidified our expansion to Danbury Hospital, adding 400 more preemie families

to the ranks of those we help each year. We are now reaching almost 1,200 new preemie families at four partner hospitals throughout Fairfield County each year! And, as always, we continue to support many of those families long after they leave the NICU, in the months and years ahead, which is sometimes when they need us most.

After these last several years of dramatic growth, 2013 has been more about "going deeper." This winter, our Board successfully completed an in-depth strategic planning mission, led by Board Member and consulting guru, Rich Goldman. With Rich's expert guidance, we strengthened our governance, our operations and our programming (read more about it on page 11). Plus, we have been working closely with our

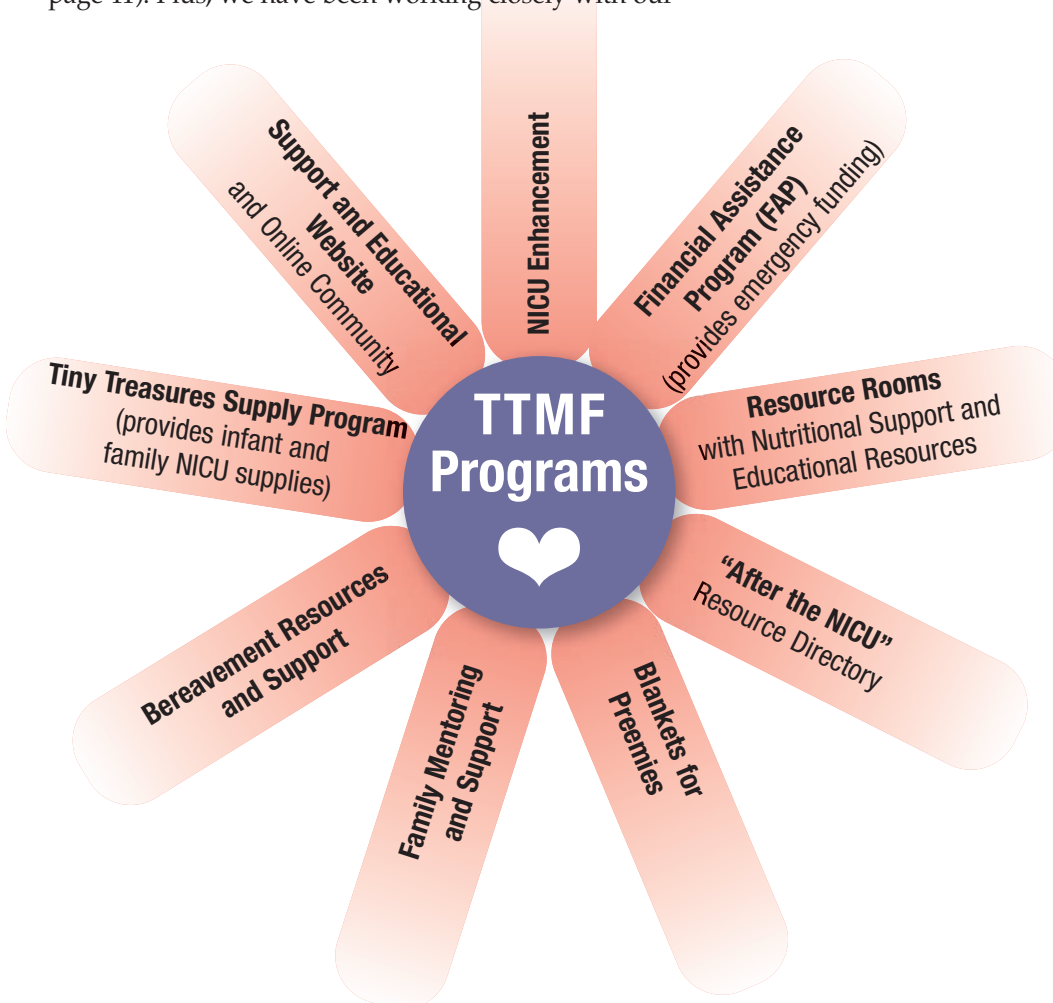

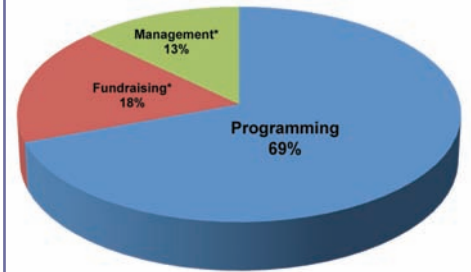

1 **The Broad Family — Addison and Ashton, Born at 32 Weeks 6 Days**

It was Christmas Eve 2012 when Jamie Broad realized she didn't feel well. She was 31 weeks pregnant with twins. The next day, Christmas Day, she decided to go to the hospital. After an examination and several tests, including an MRI, the doctors determined that Jamie needed surgery to remove her appendix. Jamie remembers, "I was worried about the babies, but everything happened SO fast." She went home on December 29, feeling sore and uncomfortable.

Only 5 days later, on January 3, Jamie's water broke.

She went straight back to Danbury Hospital. Her twins were born later that evening. Her daughter, Addison, weighed 3.15 lbs and her son, Ashton, weighed 4.3 lbs. They were immediately taken to the NICU where they were put on C-Pap machines, IVs, and feeding tubes. Jamie and her husband, Jason, were not allowed to hold the babies at first and Jamie remembers not knowing what to expect in the NICU.

Jamie says that while her babies were in the hospital, she used TTMF's Parent Resource Room a lot. She also received a Welcome Bag and a Homecare Bag with several very useful items. But the most helpful thing, by far, was the mentoring.

"It was a relief to speak with someone knowledgeable who had previously been in a similar situation and had experience with twins as well. The mentor also helped us with all of the emotions that come with having premies and gave us advice on how to handle life outside of the hospital. Other resources, such as books, are helpful, but talking with someone allowed us to ask specific questions about our personal situation."

Addison stayed in the hospital for 3-1/2 weeks as a "grower and a feeder." She needed to gain weight, learn to

feed, and maintain her body temperature. Ashton remained there for 7 weeks. They were able to take him home once he was off his nasal cannula, had gone about a week without an apnea episode, and had learned to eat and breathe on his own. Throughout the course of their stay, both babies also worked on transitioning from IVs to feeding tubes to bottle feedings. Leaving the NICU was "an adjustment" and Jamie remembers feeling nervous about not having the nurses and doctors around. But overall the transition was smooth and having both her babies home was bittersweet.

Addison and Ashton are now 6 months old and doing well. Both are receiving some physical therapy but are otherwise happy and healthy 6 month olds! ♥

**2 The Balladin Family —
Dixie, Petula and Patty,
Ayden, Born at 30 Weeks
Denise, Born at 26 Weeks**

In 1999, Dixie Balladin was working as a Certified Nurse's Aide. At the same time, our Board President, Leelee Klein was put on bed rest in Stamford Hospital 23 weeks into her pregnancy. Dixie was hired to help care for her during the day. "Dixie became my friend and savior during those long weeks because she was the grandmother of a preemie (Tekai) born at 25 weeks, and she knew how to keep me calm and positive about my babies."

When Leelee's twin girls were born at 26-1/2 weeks, Dixie brought her daughter Petula and 2-year-old grandson Tekai to the hospital to meet Leelee. "When I met Petula and Tekai, it gave me incredible reassurance and support which I desperately needed at that time." Dixie and Leelee have stayed in touch for 13 years. When her daughters both had preemies at Stamford Hospital, Dixie called Leelee for TTMF support.

In the spring of 2012, Dixie's daughter, Petula, became pregnant and was due in October. She worked in Stamford Hospital as a clinical assistant. The pregnancy was going well until she reached 25 weeks, when suddenly she began bleeding. She was admitted to the hospital and put on complete bed rest. "I was completely frustrated and scared for the baby's health," recalls Petula.

After five weeks in the hospital, Petula developed an infection. The next thing she knew her baby boy, Ayden, was born via emergency C-section and brought directly to the NICU.

Enter The Tiny Miracles Foundation. Petula remembers TTMF being extremely helpful during her NICU experience. She

wasn't getting paid during her 5-week stay in the hospital, so Petula used TTMF's Financial Assistance Program (FAP) to help her get over the rough patch. TTMF provided a stroller and a car seat as well as one month's rent. Petula also remembers volunteers calling her several times and providing emotional support while Ayden was in the hospital. She also loves the fleece blanket Ayden received after he was born and plans to keep it as a reminder of his time in the NICU and TTMF's support.

Since coming home from the hospital, Petula reports that Ayden is doing great! He's 11 months old but since he climbs and gets into everything, she laughingly insists he acts like "he's a terrible two!"

Only six months later, Petula's sister Patty was pregnant and due in May. But in February, an at-home nurse noticed during a routine checkup that Patty's blood pressure was high. Patty was sent by ambulance to a hospital in New Hampshire in the middle of a snowstorm. When the doctors discovered Patty had preeclampsia, they performed an emergency C-section and delivered baby Denise at 26 weeks and 6 days. She was

2 lbs 2 oz.

Denise was transferred to Stamford in early March. Patty remembers, "Going through this was really hard." But having TTMF's support was very helpful. She spoke with several different mentors, including her mother's friend Leelee. "Hearing about it from a different person who went through it, you have hope," says Patty.

Patty loved getting several preemie resource books from a TTMF mentor that were reassuring and helpful. A few months later, she passed them on to a friend who had just had a preemie. Patty also received an equipment package and one month's rent from TTMF's FAP program which alleviated some of the financial stress caused by having Denise in the NICU. One of the most emotional things she received, however, was "a really nice blanket from some kids at Tokeneke." She still has the blanket and plans to keep it.

Denise came home from the hospital at the end of April. Patty says, "She is wonderful! And she eats, and eats, and eats!" ❤️

3 The Regula Family — Riley,
Born at 31 Weeks

In Kathleen Regula's own words:
My husband and I are so thankful for all that Tiny Miracles has provided us throughout our journey this far and we are more than happy to share Riley's story.

Our story begins during the middle of my 31st week of pregnancy. I was having a wonderful pregnancy and was feeling great.

One Thursday morning I woke up and, as I went about my normal morning routine, I felt a little more discomfort than usual. I figured it was just me, anxious about being in my third trimester. I never imagined I would have a premie.

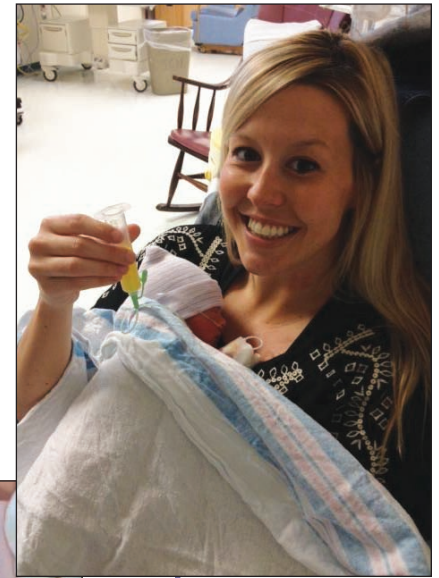
Although I went to work that morning (I'm a third grade teacher), I left the school at midday to get checked by my doctor. I dropped my students off at an assembly, told them I would be back to pick them up at the end, and ran out the door, even leaving my purse behind with the intention of returning just a little while later.

The next thing I knew, I was at the doctor's office hearing "bed rest" and "shortened cervix," and then I was on the way to the hospital for further examination. I called my husband and assured him he should stay at work because I was certain everything would be fine and I would be home with dinner on the table when he got home. My mom met me at the hospital. After I was hooked up to monitors for several hours, my doctor came in and I soon realized I wouldn't be home for dinner that night, or the next. I would be in the hospital receiving magnesium sulfate to slow the contractions, and two steroid shots to help with my baby's lung development. Our goal was to get to 34 weeks. After two days in the hospital I was sent home on strict bed rest for the remainder of my pregnancy.

I spent only 20 hours at home. That night I started contracting. I packed a bag and my husband brought me back to the hospital. The next thing I knew, doctors and nurses were flooding the room in

preparation for our baby. I will never forget when my husband's eyes locked with mine; there was no turning back. Our child was coming today, ready or not.

Less than an hour later our daughter arrived. I got to hold my daughter for the first time. She was 4.1 pounds and 17 inches long. That would be the last time for a while that we saw our daughter without tubes or IVs. It was the start of the longest 50 days of our lives; it was the start of our NICU journey.

When you tell people you had a premie, fear immediately fills their eyes. The same fear they may have felt when they saw Riley for the first time in her huge isolette. But that was not an emotion that came to me. All I could think about was how perfect she was. She was mine, no matter what, and no tubes or strange foreign wires would deter me from the overwhelming devotion I felt towards my daughter.

I spent every day traveling to the hospital and sitting next to Riley in the NICU. My husband would come later at night, and as time progressed we were able to feed her and hold

her. The wonderful nurses and doctors explained every step of the way to us and taught us so much. The Tiny Miracles Foundation also became part of my NICU experience. I spoke to several different TTMF mentors and thought they were reassuring and encouraging. We received a Mother's Day Miracle Charm bracelet from TTMF and their welcome and home Care bags had special supplies to help us.

Riley came home after seven weeks in the NICU, tube- and monitor-free. I was sad to leave our NICU family with whom we had become so close, but ecstatic to finally have our child home.

Riley has continued to thrive since she has been home. Today Riley weighs a little over 10 pounds and is making really good progress. It may not have been the ideal first childbirth experience, but it has made me a much stronger mother than I think I would have otherwise been. Our experience is one I will never forget; it makes you truly count your blessings. We are living proof that miracles do happen, even really tiny ones. ♥

Blankets for Premies

Tiny Miracles was thrilled to once again partner with Middlesex Middle School to successfully roll out our 7th annual Blankets for Premies Program. The effort was a three-step process that ultimately yielded over 1000 blankets!

Phase One was pre-cutting, which took place at the Wee Burn Country Club in Darien. Wee Burn donated space for three days so that 100 volunteers from all over Fairfield County could cut thousands of yards of fleece. Pre-cutters included local Girl Scout troops, senior citizens from Maplewood at Darien, local students, parents of premies, and kind-hearted volunteers who just wanted to help.

Phase Two involved with the energetic students at Middlesex Middle School in Darien, who completed the huge majority of blankets. The 7th grade Blue Team at MMS, under the leadership of science teacher and preemie mother Kelly Depiano, completed over 450 blankets. The kids spent some time learning about community service, premature birth, and how the blankets help the premies; the rest of the day was devoted to knotting, finishing and packaging the blankets.

Phase Three occurred thanks to the Darien High School Community Council, led by Courtney Kyritz, a DHS senior. In an inspiring one-day effort, all DHS students were invited to pop into the "Chill Room" during their free periods to transform some of the pre-cut fleece into 30 completed blankets. DHS students weren't the only ones helping with Phase Three. It was also powered by several Girl Scout troops, New Canaan Country Day School students, and other volunteer groups in town, whose joint contributions finished the remainder of the blankets. What an inspiring team effort! ❤️

What makes these blankets so special?

The Keepsake Fleece Isolette Cover Blankets are so popular with preemie families and NICU nurses that Tiny Miracles is asked to deliver over 1,200 blankets per year — more than any other supply we offer!

Why? These blankets are often the first positive gesture a family receives after the shock of their baby being born prematurely, and they tend to carry a tremendous significance to these families. In addition, the blankets serve several important psychosocial and developmental functions, including:

- ♥ Help regulate babies' sleep patterns by providing a dark, quiet environment.
- ♥ Improve fragile premies' neurological development by shielding them from excess light and noise in the NICU.
- ♥ Help parents identify their baby's isolette by their own beautiful blanket.
- ♥ Brighten the NICU by adding color and cheer.

Tiny Treasures Program

This past spring, our Tiny Treasures Committee, led by Terri Dusch, took on the project of replenishing our Tiny Treasures supply bags. The Committee managed to purchase and secure donations for an incredible 1600 bags! The Tiny Treasures program includes two separate supply packages: the Welcome Bag and the Home Care Bag.

The Welcome Bag is given to families while their babies are in the NICU. In addition to literature about TTMF and other parent resources, the bags include a bonding doll and breast pumping supplies. The bonding doll, which is made of cotton and other materials that retain scent, plays a critical role in mother/baby bonding. A mother takes the doll home and sleeps with it overnight so that it absorbs her scent. The doll is then placed in the baby's isolette in the NICU. Studies show that a newborn baby is able to recognize his/her mother's scent and it has a calming, soothing effect on the baby.

The Home Care Bag includes helpful items such as preemie-sized diapers and clothing. It also contains important literature from the March of Dimes, such as the informative booklet, "Bringing baby home from the NICU" and helpful apps to aid parents with tracking medications and other preemie care at home.

Special thanks go to the wonderful companies who donated items for our Tiny Treasures bags, including the March of Dimes (over 1600 brochures and booklets), Hank & JoJo (800 pairs of preemie socks), Rockabye Baby!® (800 digital musical downloads) and Lansinoh (800 packets of nipple cream).

NICU Enhancement Program

One of our goals at Tiny Miracles is to work with our partner hospitals to enhance the services they provide to premature babies and their families.

In 2012, we were thrilled to be able to provide a \$10,000 grant each to Norwalk Hospital and Stamford Hospital to be used for NICU services. Here's how each hospital used the funds:

Norwalk Hospital

- Sent three NICU nurses to San Francisco to attend the 10th National Advanced Practice Neonatal Nurses Conference, where they learned valuable skills related to topics including Neonatal Abstinence Syndrome, Hyperbilirubinemia, Hypo- and Hyperglycemia, and Persistent Pulmonary Hypertension. Those nurses are now sharing what they learned with other staff.
- Purchased an interactive, mobile patient education program called NICU Knowledge. It allows family members to familiarize themselves with what to expect while their newborn is in the NICU. The NICU Knowledge educates parents about the NICU team, explanations of medical terms and equipment, and instructions on caring for their babies while in the NICU environment and after going home.

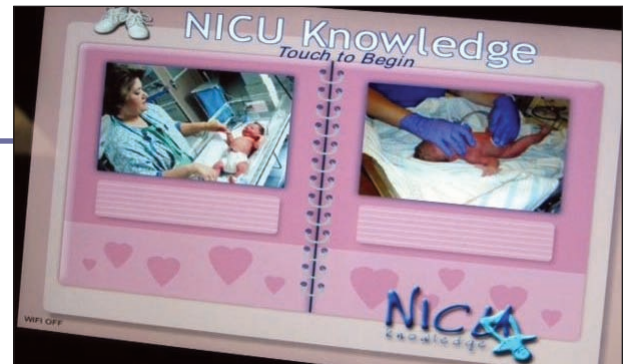

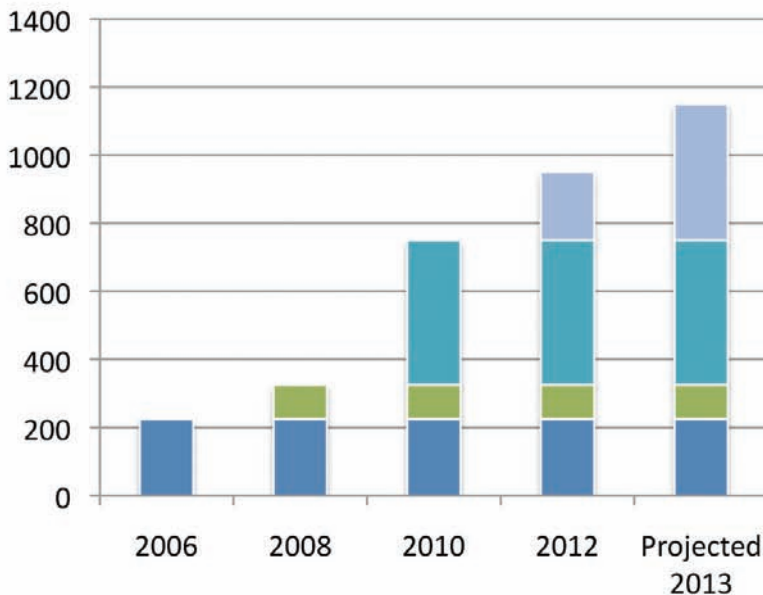

In 2005, their twin girls Jessica and Samantha were born extremely early, and several weeks later, they lost Jessica due to complications during her NICU journey. The Goldmans contacted TTMF for support, as well as referrals for a baby nurse for Samantha. Inspired by TTMF's grassroots programs, both Jami and Rich joined our team of volunteers soon after they brought Samantha home. Their beautiful miracle daughter is now 9 years old and has a little brother Mathew who is 8.

Rich joined the TTMF board in 2006 and immediately became a trusted adviser. Rich has been our "go to" person for hiring and managing our employees as well as helping us navigate any complex business questions. 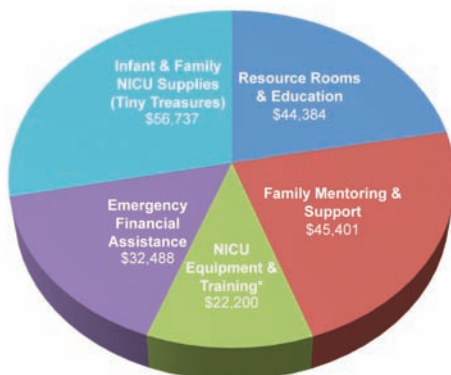

In 2012, TTMF helped nearly 1,000 local preemies and their families and our four partner NICUs with over \$200,000 of services and supplies.

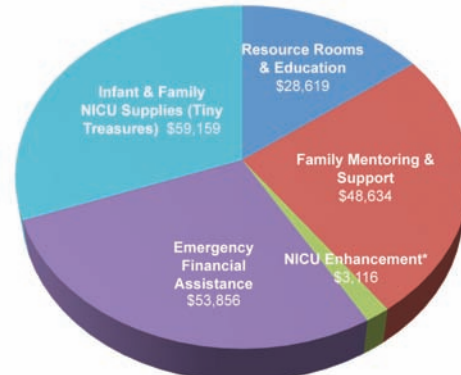

Strategic Planning

Over the past nine years, many wonderful members of our Board of Directors have helped us become the organization we are today. Very special thanks go out to all of them!

This year, one of our founding board members, Lisa Tantillo of Westport has decided to move on to new endeavors. Among the many contributions she has made to TTMF, she developed our first program, the support web site. Lisa stayed up many long nights and provided all of the content, layout, and professional knowledge to establish and launch www.ttmf.org in 2005. Lisa continued to monitor and update the content and layout of our web site with our designer, Jessica Sheeran of Sheeran Designs. Lisa also collaborated on multiple fundraising efforts, wrote several original grants and was our primary editor for all of our written materials. Lisa will continue to support TTMF as an active volunteer parent mentor at Bridgeport Hospital and as a special committee member for our Emergency Financial Assistance Program. She will remain on our Honorary Board. We have been blessed with Lisa's nine years of service on our Board.

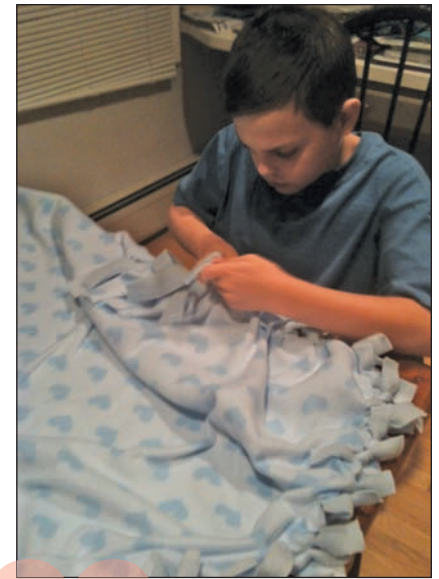
All year long, there are wonderful people doing amazing things for TTMF. Here is a quick snapshot of some of them:

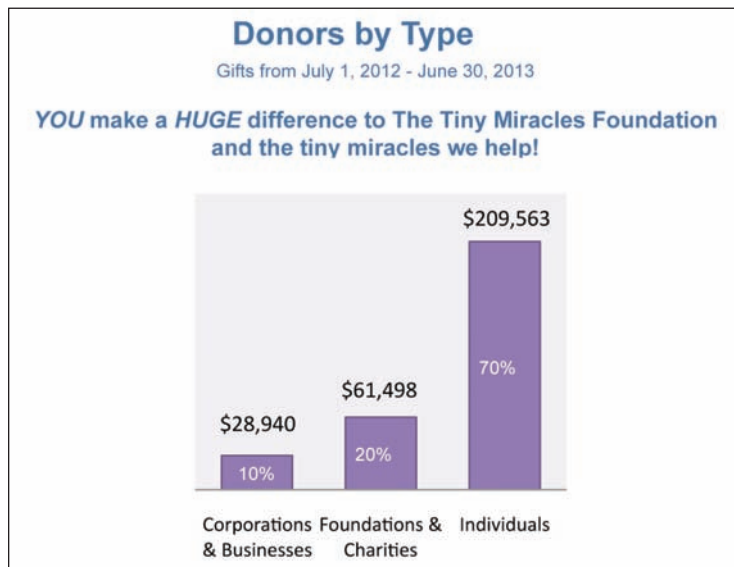
