CAROL BAUER RETIRING ADVISOR AND VOLUNTEER

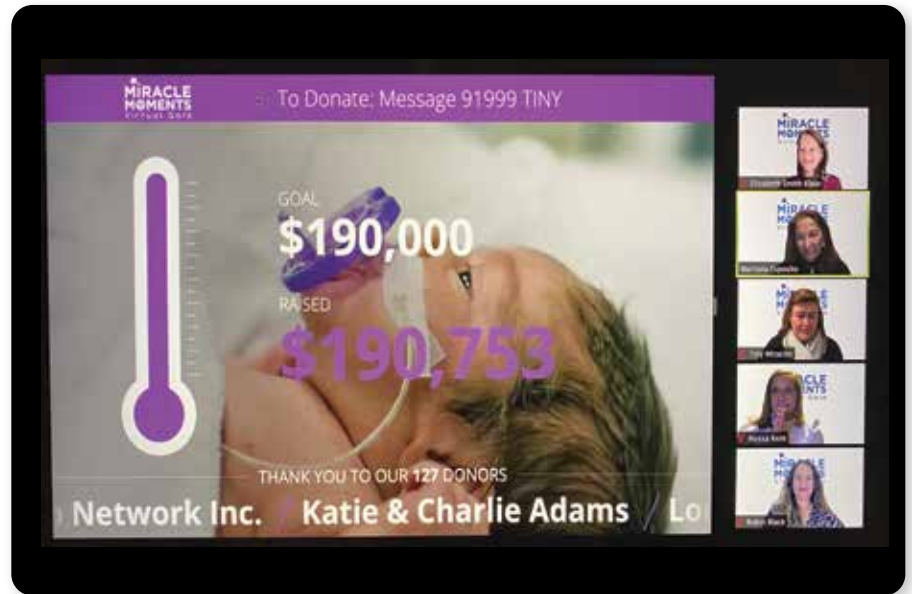

MIRACLE STORY: THE PEREZ-MADRIGAL FAMILY

ENGLISH

When Tanya Perez-Madrigal was ten weeks pregnant she was hospitalized with Covid. It was a terrifying experience. After recovering from Covid she was diagnosed with placenta previa and shortly after, Tanya was on her way to work when she realized she was bleeding, and her water broke. She was rushed to Norwalk Hospital, and on June 6, 2021, Matias N. Perez-Madrigal was born, weighing 2 pounds 2 ounces at 26.6 weeks gestation.

Tanya went back to work three weeks after Matias's birth to save her maternity leave and keep income flowing to pay their mortgage and keep their daughter, Valentina, in daycare. Her husband's job in construction was not consistent, and he needed to take several weeks off. This time off resulted in more income loss.

ESPAÑOL

Cuando Tanya Pérez-Madrigal estaba embarazada de diez semanas fue hospitalizada con Covid. Fue una experiencia aterradora. Después de recuperarse del Covid le diagnosticaron placenta previa y poco después, Tanya se dirigía a su trabajo cuando se dio cuenta de que estaba sangrando y se le rompió el agua. Fue llevada de urgencia al Hospital Norwalk, y el 6 de junio de 2021, nació Matías N. Pérez-Madrigal, con un peso de 2 libras y 2 onzas a las 26.6 semanas de gestación.

Tanya volvió a trabajar tres semanas después del nacimiento de Matías para ahorrar su licencia de maternidad y mantener los ingresos fluyendo para pagar su hipoteca y mantener a su hija, Valentina,

The Tiny Miracles Foundation provided emergency financial assistance to help them cover their mortgage for one month. This relief allowed Tanya to save her maternity leave for when Matias came home and eased financial stress.

The last two weeks of Matias's NICU journey was challenging. Matias was transferred to Hartford for the surgery, which caused his parents' incredible anxiety. His father stayed home with his sister and Tanya made the journey to Hartford. Tanya was supported by her Tiny Miracles Foundation peer mentor the entire time. She was anxious, exhausted from work, pandemic restrictions, and her newborn. Her mentor and Tiny Miracles Foundation Facebook group provided a calming, reassuring voice of understanding, relatability, and encouragement to help keep things in perspective. Tanya was able to share her

emotions with a group of people who had experienced a similar situation.

Matias came home on August 26th after 76 days in the NICU.



en la guardería. El trabajo de su esposo en la construcción no era consistente, y necesitaba tomarse varias semanas de descanso. Esta vez resultó en más pérdida de ingresos.

The Tiny Miracles Foundation fue alertado de la situación por el mentor de pares de Tanya. The Tiny Miracles Foundation proporcionó asistencia financiera de emergencia para ayudarlos a cubrir su hipoteca durante un mes. Este alivio le permitió a Tanya guardar su licencia de maternidad para cuando Matías llegara a casa y aliviara el estrés financiero.

Las últimas dos semanas del viaje de Matías a la UCIN fueron desafiantes. Tenía dificultad para respirar después de sus vacunas y necesitaba cirugía de hernia. Matías fue trasladado a Hartford para

la cirugía, lo que causó la increíble ansiedad de sus padres. Su padre se quedó en casa con su hermana y Tanya hizo el viaje a Hartford. Tanya fue apoyada por su mentor compañero todo el tiempo. Estaba ansiosa, agotada por el trabajo, las restricciones pandémicas y su recién nacido.

Su mentor y grupo de Facebook Tiny Miracles Foundation proporcionó una voz tranquilizadora y tranquilizadora de comprensión, relatividad y aliento para ayudar a mantener las cosas en perspectiva. Tanya pudo compartir sus emociones y ser comprendida.

Matías regresó a casa el 26 de agosto después de 76 días en la NICU.

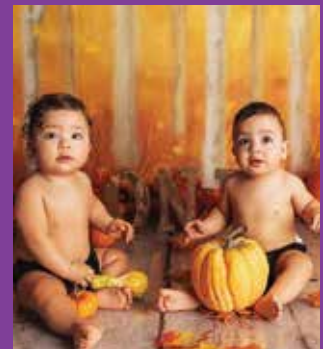

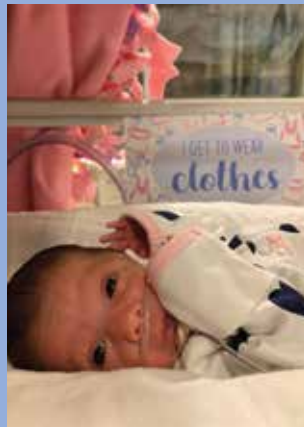
